CONSTITUTION, BYLAWS, AND CONTINUING RESOLUTIONS of the EVANGELICAL LUTHERAN CHURCH IN AMERICA® Chapter 8.

RELATIONSHIPS

8.50. RELATIONSHIP WITH OTHER LUTHERAN ORGANIZATIONS

- **8.51.** This church may establish relationships with Lutheran organizations, institutions, or agencies whose purposes are compatible with its mission and ministry. Policies and procedures to create and implement these relationships shall be adopted by the Church Council.
- **8.52.** This church shall not, in any manner, be responsible for the debts or liabilities of other Lutheran organizations, institutions, or agencies, whether independent of or affiliated with this church.

8.60. RELATIONSHIP WITH INTERCHURCH AGENCIES, INSTITUTIONS, AND COUNCILS

- **8.61.** The congregations, synods, social ministry institutions and agencies, and churchwide organization may establish or affiliate with interchurch agencies and councils in relationships that will reflect this church's objectives of sharing with other faith communities in study, dialogue, and common action, in accordance with adopted policies governing such associations.
- **8.61.01.** Policies governing ecumenical, inter-Lutheran, and interfaith activities shall be recommended by the presiding bishop of this church to the Churchwide Assembly for its adoption.
- **8.61.02.** Formal membership in interchurch agencies and/or councils shall be by action of the Churchwide Assembly in all relationships involving national or international involvement, by the Synod Assembly in its geographic area, and by congregations in community settings, with each affiliation by any congregation, synod, or churchwide organization to be in accordance with the policies of this church.

8.70. OFFICIAL CHURCH-TO-CHURCH RELATIONSHIPS

- **8.71.** This church may establish official church-to-church relationships and agreements. Establishment of such official relationships And agreements shall require a two-thirds vote of the voting members present and voting in a Churchwide Assembly.
- **8.72.** Policies and procedures to implement church-to-church relationships of full communion established by action of a Churchwide Assembly may be recommended by the appropriate officer or churchwide unit, reviewed by the Conference of Bishops, and adopted by the Church Council.
- 8.72.10. Ecumenical Availability of Ordained Ministers and Rostered Laypersons
- **8.72.11.** An ordained minister of this church, serving temporarily in a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America, may be retained on the roster of ordained

8.60. RELATIONSHIP WITH INTERCHURCH AGENCIES, INSTITUTIONS, AND COUNCILS

8.61. The congregations, synods, social ministry institutions and agencies, and churchwide organization may establish or affiliate with interchurch agencies and councils in relationships that will reflect this church's objectives of sharing with other faith communities in study, dialogue, and common action, in accordance with adopted policies governing such associations.

- **8.61.01.** Policies governing ecumenical, inter-Lutheran, and interfaith activities shall be recommended by the presiding bishop of this church to the Churchwide Assembly for its adoption.
- **8.61.02.** Formal membership in interchurch agencies and/or councils shall be by action of the Churchwide Assembly in all relationships involving national or international involvement, by the Synod Assembly in its geographic area, and by congregations in community settings, with each affiliation by any congregation, synod, or churchwide organization to be in accordance with the policies of this church.

8.70. OFFICIAL CHURCH-TO-CHURCH RELATIONSHIPS

- **8.71.** This church may establish official church-to-church relationships and agreements. Establishment of such official relationships And agreements shall require a two-thirds vote of the voting members present and voting in a Churchwide Assembly.
- **8.72.** Policies and procedures to implement church-to-church relationships of full communion established by action of a Churchwide Assembly may be recommended by the appropriate officer or churchwide unit, reviewed by the Conference of Bishops, and adopted by the Church Council.
- 8.72.10. Ecumenical Availability of Ordained Ministers and Rostered Laypersons
- **8.72.11.** An ordained minister of this church, serving temporarily in a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America, may be retained on the roster of ordained
- **8.72.12.** An ordained minister of a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America may be authorized by the synodical bishop to serve in a congregation or employing entity of this church. Such service shall be rendered under a contract between the congregation or employing entity and the ordained minister in a form proposed by the synodical bishop and approved by the congregation or employing entity. Any such service shall be in accord with churchwide policies developed at the direction of the presiding bishop and secretary, reviewed by the Conference of Bishops, and adopted by the Church Council of the Evangelical Lutheran Church in America.
- **8.72.13.** Whenever an ordained minister, associate in ministry, deaconess, or diaconal minister of the Evangelical Lutheran Church in America is to serve or is serving in a church body with which a relationship of full communion has been declared and established by the Churchwide Assembly, or whenever an ordained minister of a church body with which a relationship of full communion has been so declared and established is to serve or is serving in this church, a full sharing of relevant information concerning such rostered leader's experience and fitness for ministry is expected between the synodical bishop (or other appropriate office or entity) of this church and the appropriate person, office, or entity in the other church. Relevant information related to fitness for ministry shall include, but is not limited to, any information concerning disciplinary proceedings or allegations that could result, or could have resulted, in disciplinary proceedings.
- **8.72.14.** An ordained minister from a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America may be granted the privilege of both voice and vote in the Synod Assembly during the period of that ordained minister's service in a congregation of this church, in accord with ELCA churchwide bylaw 8.72.12.
- **8.72.15.** The availability of ordained ministers from a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America shall be understood normally in three categories: availability to serve in an occasional situation; availability to meet an extended need, including service in "yoked parish" settings; and availability for a transfer of roster status.
 - a. Occasional service: An occasional situation is defined as one in which an ordained minister of a church body with which a relationship of full communion exists may be asked to preach or administer the sacraments in an ELCA congregation on an occasional basis with the authorization of the synodical bishop.
 - b. Extended service: An ordained minister of a church body with which a relationship of full communion exists may be invited to serve as the pastor of an ELCA congregation for an extended period of time, yet remain an ordained minister of his or her present church body. Such a person would be expected to preach, teach, and administer the sacraments in an ELCA congregation in a manner that is consistent with the Confession of Faith of the Evangelical Lutheran Church in America and to live in a manner consistent with the ministerial policy of this church. Such service shall be rendered only as authorized by the synodical bishop in order to serve the ministry and mission needs of the ELCA in a given situation.
 - c. Transfer: An ordained minister of a church body with which a relationship of full communion exists who seeks to serve indefinitely within the ordained ministry of the Evangelical Lutheran Church in America may apply for admission to the roster of ordained ministers of the Evangelical Lutheran Church in America and be approved through the candidacy process for admission to the roster. Such an ordained minister would then become an ELCA pastor upon receipt and acceptance of a regular call and installation in an ELCA congregation or other setting.
 - d. Roster status in more than one church body is precluded in the Evangelical Lutheran Church in America. As required by ELCA churchwide constitutional provision 7.22. and bylaw 7.31.11., ordained ministers on the roster of the Evangelical Lutheran Church in America must accept and adhere to this church's Confession of Faith, as well as abide by this church's standards and policies for ordained ministers.
- **8.72.16.** An ordained minister, associate in ministry, deaconess, or diaconal minister of the Evangelical Lutheran Church in America, while serving in an ecumenical setting, remains subject to the standards, policies, and discipline of the Evangelical Lutheran Church in America. An ordained minister of a church body with which a relationship of full communion exists is understood

by the Evangelical Lutheran Church in America as subject to the standards, policies, and discipline of the church body in which the ordained minister is rostered or holds ministerial membership.

Such an ordained minister, while serving in an ELCA congregation or other ministry, is expected to abide by the standards and policies of this church related to ordained ministers.

- **8.72.17.** When an ordained minister from a church body with which a relationship of full communion has been declared and established by a Churchwide Assembly of the Evangelical Lutheran Church in America completes a contract for extended service, the synodical file on that ordained minister shall be sent to and retained by the Office of the Secretary.
- **8.73.** This church acknowledges the relationship established through the Lutheran World Federation as a communion of member Churches which confess the triune God, agree in the proclamation of the Word of God, and are united in pulpit and altar fellowship. The bylaws on ecumenical availability of ordained ministers under relationships of full communion shall apply to such service within this church of ordained ministers from other member churches of the Lutheran World Federation.
- **8.74.** This church, in accord with constitutional provision 2.05., acknowledges as one with it in faith and doctrine all churches that accept the teaching of the Unaltered Augsburg Confession and understands that altar and pulpit fellowship with congregations and other entities of such churches may be locally practiced. Local practice of altar and pulpit fellowship, in accord with churchwide constitutional provision 2.05., is subject to the approval of the Synod Council, upon endorsement by the synodical bishop. Notice of such approval is to be given to the presiding bishop as the chief ecumenical officer of the Evangelical Lutheran Church in America.
- **8.74.01.** The approval is granted initially for one year only and must be reviewed and approved annually by the Synod Council. Any time that the local practice of altar and pulpit fellowship no longer serves the mission and ministry needs of this church, the synodical bishop may withdraw endorsement and the Synod Council may withdraw the approval.
- **8.74.02.** An ordained minister of a church body with which the ELCA is not in full communion who is serving in a ministry involving the local practice of altar and pulpit fellowship with an ELCA congregation is understood to be subject to the standards, policies, and discipline of the church body in which the ordained minister is rostered or holds ministerial membership. Such an ordained minister, while serving an ELCA congregation or other ministry, is expected to abide by the standards and policies of this church related to ordained ministers. An ordained minister of this church, while serving in a ministry involving the local practice of altar and pulpit fellowship with a non-ELCA congregation, remains subject to the standards, policies, and discipline of the Evangelical Lutheran Church in America.
- **8.75.** Synods of the Evangelical Lutheran Church in America and units of the churchwide organization are encouraged to engage in Cooperative work, wherever possible, with churches that accept the teachings of the Unaltered Augsburg Confession. Units engaging in this work shall advise the presiding bishop of such developments.

*C9.03. Consistent with the faith and practice of the Evangelical Lutheran Church in America,

- c. Every pastor shall:
 - 3) impart knowledge of this church and its wider ministry through distribution of its periodicals and other publications; and

THE CREED

THE THIRD ARTICLE

I get to read a lot of newsletters-a task I like because it's always interesting to see what's going on around the synod. The other day while scanning a publication, I noticed this quote from Corrie Ten Boom, "Security is having the Word of God in your own language. Peace is having the Word of God in your heart." My immediate reaction was to add these words: "Mission is sharing the Word of God with others." A little further down the page in the newsletter the following plea appeared, "Lord, walk beside me with your arm over my shoulder and your hand over my mouth." I murmured to myself, "how very Lutheran (or Midwestern or whatever it is that makes us reluctant to speak out-even to share the Good News of Jesus Christ)!"

It's time to tell the story-and that's precisely what this new publication *God's Work. Our Hands* is intended to do! Many people throughout our synod are busy doing God's work with their hands. Let's share those stories! Let's tell everyone how God's ever-present love is manifested through our efforts, large and small. When you bake cookies and ship them off to a college student who is away from home for the first time; when you take time to visit the elderly neighbor who recently lost a spouse; when you rake a lawn with your youth group; or read a Bible story to your grandchild, you are doing God's work and I want to share your story.

Years ago, a friend of mine commented, "There are two kinds of people-those who do the work and those who talk about it." I'm not sure I agree. I'd like to think that those who do the work can also be those who talk about it. Let's set aside our Lutheran/Midwestern modesty and talk about it. Why? Not because it lifts us up, but because it lifts others to hear the stories, to realize that God is indeed among us, working through us, because there are no hands but ours. Part of the "work" involves sharing the story so others may know that God's love surrounds us on a daily basis, even in the mundane chores. What about the quotes from that newsletter? Maybe we should change the message to "Lord, walk beside me with your arm over my shoulder and give me the words to say so others will know you, too!"

CALL PROCESS

"Our pastor is leaving – so what do we do?" This is how most congregations enter the call process. The synod takes the first step when the bishop appoints, with the concurrence of the Congregation Council, an interim pastor to provide pastoral ministry to the congregation and assist in some parts of the call process. A member of the synod staff will meet with the Congregation Council and Call Committee to help everyone understand the whole process:

- + Pray for the Holy Spirit's guidance in matching a pastor with a parish.
- + Experience a transition from the ministry of the previous pastor saying good-bye to the last pastor.
- + Develop a Ministry Site Profile encompassing the history of the congregation, current ministries, and the direction God is calling the ministry of the congregation in the future.
- + Determine a compensation range for a prospective pastor.
- + Interview candidate to serve as pastor.
- + Recommend a candidate to the parish for a ballot vote that requires a 2/3 majority to extend the call.
- + If the candidate accepts the call, rejoice and warmly receive the candidate.

The discernment of whether God is calling a pastor to a parish is done jointly between the bishop, the parish, and the pastor.

+ Read Ephesians 4:4-16. Where does the pastor fit in with the whole ministry of all the people of God? How does that happen? What kind of pastor would fit this way in your congregation? How much responsibility for the ministry in the parish do the members take? + Read 1Timothy 3:1-7. How do these personal characteristics of a pastor in the first century apply to pastors today? What other characteristics would you add if you were calling a pastor to your parish?

+ Read 2Timothy 4:1-5. Does this apply only to a pastor or does this describe everyone in the parish? Would a pastor be excited to serve a parish that acted this way? Would a parish be excited to receive a pastor who had these priorities?

Scripture – Romans 10:8-15; 1Timothy 4:6-16

THOUGHT FOR THE DAY

Paul writes to the Romans about the dynamics of faith. Faith comes by hearing! Hearing comes by Christians speaking words of truth and faith!

+ Who are the ones sent to speak? Only pastors?

+ Pastors are called to public ministry and leadership. How does that affect their speaking words of truth and faith so that others may hear and believe?

+ Paul writes to encourage Timothy about his public ministry and leadership.

What are some of the key joys and responsibilities of a pastor?

A congregation in the call process is called to focus on its ministries and the pastoral leadership needed for those ministries to thrive. What are your key ministries? How would you set your priorities among your ministries? How would a pastor encourage and enable those ministries? Pray for the call process that God will provide a faithful pastor for your congregation!

From the Bishop

In the Evangelical Lutheran Church in America, we believe that it is our Lord Jesus Christ, through the power of the Holy Spirit, who guides the call process. We trust that the Spirit works with and through pastoral candidates, congregations, and synods – and when these three agree, we are bold to say that we have discerned the will of God.

Know that pastoral transitions are a regular and natural concurrence in the life of a congregation. During the interim period, congregations have a pastor dedicated to the specialized ministry of leading communities of faith through a process of prayer, reflections, and self-discovery to discern what God is calling them to be and do.

The synod staff is also specifically trained in this work and will partner with Call Committees and Congregation Councils to find appropriate pastoral leadership. Healthy pastors and healthy congregations looking forward in mission is our goal. We hold congregations in prayer during this time of transition in weekly staff devotions, and we covet your daily prayers that God will guide the process and strengthen our partnership in the gospel for the sake of the world.

Many paths to rostered leadership

Once upon a time, in our predecessor church bodies, there was just one way to become a leader in the church. One went to college (most likely a college affiliated with the denomination) and then to seminary. Finally, the individual was ordained into word and sacrament ministry. Oh, times have changed!

In June, the Candidacy Committee of our synod met with four gifted people who are beginning the work to become leaders in our church--each in a unique way.

The first candidate is studying youth and family ministry at Augsburg College and wants to be commissioned as an associate in ministry in the church. Associates in ministry choose a specific ministry emphasis, receive training in that field, and work with the Candidacy Committee to discern how their gifts may be a calling to a vocation in the church.

The second candidate is a traditional student, getting ready to graduate from college (also Augsburg). In her early 20s, she is feeling a call to ordained ministry and is looking forward to starting classes at seminary in the fall. The Candidacy Committee will explore both the internal and external call to ministry with her as she moves toward ordination.

The third person is a second-career candidate for ordained ministry who saw an opportunity in a special program called Theological Education for Emerging Ministries (TEEM). In the TEEM program, people are trained for culture-specific ministries or for work in rural congregations. The program raises up leaders from local communities to serve underserved congregations in our church.

The fourth candidate is also a second-career person who feels called to bridge the divide between church and world by becoming a diaconal minister, one consecrated to word and service rather than word and sacrament ministry. Diaconal ministers seek to lead all the

baptized to live out their baptismal identity in their daily lives. Often, they choose a specific ministry emphasis, and they examine their own spiritual journey in order to draw out the spiritual gifts of the people they serve and address the spiritual needs of the communities in which they serve.

"The call process is really a time of discernment for the congregation and its call committee, the rostered person and the synod staff to see whom God would send to serve God's people... Congregations take great care in preparing their "ministry site profile" - trying to paint a picture of their life and ministry. Rostered leaders take equal care in preparing their profiles. Bishops and synod staffs meet with congregations to ensure they understand their contexts and ministry needs. Bishops and staffs know the candidates. And the whole process is surrounded with prayer, asking the Spirit for guidance." There are a limited number of copies in the gathering area, or you may go online to Great Expectations: What Are Pastors, Churches Looking For? – The Lutheran Magazine to read about "when congregations and pastors find each other."

Companion Synod News

In 1999, the ELCA produced a strategic planning document entitled, *Global Mission in the Twenty-first Century*. The overall purpose of the plan is more effective witness to Jesus Christ. The document suggests that this can best be pursued by churches effectively walking together in companionship, as we are doing with the Evangelical Lutheran Church in Malawi (ELCM). One of the goals outlined in the strategic plan involves supporting education programs in our companion church. *Growing Together* is a joint effort of the Northwest Synod of Wisconsin and the ELCM to do just that - to work together to increase the theological capacity of pastors, evangelists and deanery women's coordinators in Malawi.

To achieve this, Pastor David Anderson, Immanuel Lutheran in Eau Claire, and Pastor Amy Odgren, synod staff, traveled to Malawi in July and taught at this year's Pastors' Academy.

Here are some of their observations about their experience:

"Why is the Academy important? Not all pastors have received formal theological education. Many of them became pastors after serving as evangelists for a period of time and attending twelve months of theological training offered by the ELCM. So for them, continuing education is necessary to build their theological knowledge base. The ELCM is a growing church and is experiencing a severe pastor shortage. One pastor may serve 10 or more preaching points. A church experiencing that kind of pastor shortage can't keep up with growth. Training short course pastors is one way to quickly get more pastors into the system."

"It's fun to be at the Academy. We see pastors renewing friendships and relationships. We see them challenging one another in friendly debates during the educational sessions. We are all learning from each other!"

The pastors of the ELCM are deeply appreciative of the teaching pastors. Here are some of their comments:

"Thank you for helping us to see things more deeply. You've worked hard and done your work to bring us such good teaching. We know it has cost you time and effort. Each day we are increasing our knowledge and learning more."

This year the nine deanery women's coordinators, a new position in the church, have been included in the academy. Three of them have had sufficient training to remain in the Pastors" Academy. The other six women were grouped together with the lay

evangelists to learn at a more basic level. They are all eager to learn, and I anticipate that in future academies they will be ready for higher-level coursework. In fact, I look at them and wonder, will one of them become the first female pastor of the ELCM? Northwest Synod of Wisconsin

Being Transformed

And all of us, with unveiled faces, seeing the glory of the Lord as though reflected in a mirror, are being transformed into the same image from one degree of glory to another; for this comes from the Lord, the Spirit. — 2 Corinthians 3:18 (NRSV) It snowed again in Baltimore this week. Even so, there have been recent days in the 50s, and more are predicted in the near future. Spring is almost here, and for many, the season of light and life has been a long time coming. Were ready to shed our winter clothes. We're ready for the ice to melt, to put away our snow shovels and for no more school delays! We're ready for the transformation of spring.

We've been reflecting on transformation here at LWR as we wrap up the 2013 Quilt Campaign. The challenge of 500,000 Quilts gave us a lot of energy last year! Quilters around the country doubled their quilting efforts, meeting more frequently, and invited friends to join the project and the fun. Camps in Nebraska and Texas jumped right in, making hundreds of Quilts over the course of several weeks of summer camp.

So, how did we do? Our warehouse staff and volunteers have been working hard to count and bale the thousands upon thousands of Quilts that came in through fall Ingatherings last October and November, with still more to count. As of the end of February, we've counted 401,931 Quilts, and we know more will come in this spring. More than the numbers, we know the powerful impact all this quilting is having on the world.

In Thailand, families sleeping in temporary shelters far from home are sheltered from the wind and rain and protected from drafts that blow through the slats of bamboo that make up their floors and walls.

In Tanzania, people living in state-run elder care facilities are able to keep warm at night, and children recovering from surgery are comforted by soft fabric and bright colors.

In the Philippines, people who lost everything in Typhoon Haiyan last November have something warm to sleep under while they work to repair and rebuild their damaged homes.

And the impact isn't just on the other side of the ocean, either. Over and over, we've heard how the Quilt Campaign transformed your congregations, quilting groups, communities and families. Through this project, we've been reminded that when God calls us

to something, it not only transforms the world but transforms us, too. What a gift — to be able to give ourselves away and yet somehow not be diminished, but rather to grow.

In celebration of these transformations at home and around the world, many congregations will join LWR in celebrating the success of the Quilt Campaign this Sunday, March 2, Transfiguration Sunday. What a perfect day to celebrate the transformative ministry of quilting, and the way God is working in our lives through these simple gifts of fabric and thread. We invite you to join us, celebrating this week or any other week! You can find resources for your celebration Sunday at <u>lwr.org/quiltcampaign</u>. So, to you who have quilted, donated fabric or money for thread or batting, or transported Quilts all over the country — thank you. Thank you for taking the risk of giving so very much of yourselves away for the sake of the world, to embody the love of Christ that runs through your hearts. And thank you for sharing how God has turned those gifts into transformation and change and growth. We thank God for each and every one of you!

2012 Mission Plan in Story

Your Northwest Synod of Wisconsin extends the mission of 199 congregations with the good news of Jesus Christ through the trust, hopes, vision, prayers, and generosity of 96,635 baptized members.

The energy and resources of your synod are focused in four key areas:

- 1. Mission Partners
- 2. Congregational Support
- 3. Leadership Development

4. Churchwide Support

Each of these first three areas include a proportionate share of synod staff salaries, travel, and office expenses. The fourth area is financial aspect of the covenant connection between synods and the churchwide expression of the Evangelical Lutheran Church in America. Each of these areas has a story rooted in the mission of Jesus Christ: to redeem the world.

The mission plan of the synod is funded in two ways -

91% of the mission plan is undesignated mission support from congregations.

2012 mission plan = \$1,410,000.

9% of the mission plan is grants from churchwide and interest income.

2012 mission plan = \$140,800.

1. Mission Partners

Mission partners are groups of fellow disciples ministering in very specific areas of focus in God's kingdom. Through our synod's mission plan, we joyfully give direct support to these eight mission partners:

- The ELCA seminaries of Region 5 Wartburg Theological Seminary in Dubuque, Iowa Lutheran School of Theology in Chicago, Illinois
- ELCA Lutheran Campus Ministry centers on three University of Wisconsin campuses: U of W Eau Claire, U of W Stout in Menomonie, and U of W – River Falls
- An ELCA college Augsburg College in Minneapolis, MN
- Wisconsin Council of Churches
- ELCA Region 5 operational support
- First Call Theological Education among the six synods of Wisconsin and the Upper Peninsula of Michigan
- The Lutheran Office for Public Policy of Wisconsin
- The Twin Ports Ministry to Seafarers in Duluth, MN

Each of these ministries has a wealth of stories of their own, and our connection with them enriches God's world. We commit 17% of all undesignated gifts to the Northwest Synod of Wisconsin to these eight mission partners through direct support (\$195,185) and synod staff time and resources given to them (\$47,853).

2. Leadership Development

3. Congregational Support

Every congregation in the Northwest Synod of Wisconsin is stronger together than alone.

All these partners in the Gospel build up your local congregation by giving generously to the synod's mission plan. Your synod staff is committed to fostering healthy congregations engaged in vibrant mission in their communities. In fact, the majority of your synod staff's time is spent in support of the mission of the congregations on the front lines of ministry!

Through the call process, guest preaching and teaching, installations, Biblical stewardship campaigns, Book of Faith Initiative, conferences, workshops, consultations, redevelopment of congregations, conflict resolution, anniversaries, congregation council retreats, synod assembly, secretarial support, and resources, your synod staff works hard to be the support staff to all the baptized of this synod. Dear Co-Workers in the Gospel,

I write to you about money. It is a ministry resource and it is a way that we express our part in something larger than ourselves or our congregations. Please do two things for me:

- 1. Be sure that you are paid up to date with what you planned to give to Undesignated Mission Support for 2012.
- 2. Reflect with your Congregation Council how you can move to and beyond being a tithing congregation, that is giving at least 10% of your offerings to Undesignated Mission Support.

Some of you may know that I am leaving the synod office to become pastor of a congregation in southern Wisconsin. As I prepare to return to the parish, I have been thinking about how honored I have been to walk with you in many and various ways through these past five years. I have also been thinking about how vitally important synod ministry is. In moving towards a mission mindset, in the call process, in ecumenical relationships, in disaster relief, in campus ministry, in raising up leaders, in encouragement, in learning, in sharing the good news of Jesus Christ, without a doubt we are stronger together.

However, the continued shrinking mission plan (budget) of this synod hampers our work. Over the past ten years, the synod mission plan has shrunk by 13.6% in real dollars. Factor in inflation and the ministry power of our synod has diminished by 32.5%. Out of 199 congregations, fewer than 10% give 10% or more to Undesignated Mission Support. Much of that can be blamed on the economy, and some of it can be blamed on the downsizing of our congregations. But the search for excuses only distracts us from focusing on the only real way forward: basic biblical principles of financial stewardship.

Does your congregation designate a certain percentage of offerings to go to the body of Christ in a no-strings-attached (undesignated) kind of way? Or do you simply carry over what you did before and add a little "if you can"? Does your congregation give from your first fruits? Or do you save that "synod bill" until the end "if we have enough left over"? Does your congregation celebrate giving as an act of worship and your partnership with the whole church as a blessing? Or is the offering a time of shame and guilt and Undesignated Mission Support are your "dues"?

The congregation I am going to lead went through significant conflict several years ago and reduced their undesignated mission support to 5%. Christ has brought healing, but I plan to work with the Congregation Council to rediscover the joy of generosity and to develop a strategy for getting back to 10% no-strings-attached, pure trust in God, joyful giving to the wider church. Will you join me in this important work?

Frameworks: Patterns for Living and Believing Today [Douglas Alan Walrath]

A "framework" consists of perspectives through which an individual approaches living and believing. Each person's framework is molded fundamentally by certain key social and cultural phenomena. Persons who grow up together through experiences unique to their time and hold common interpretations of these experiences form a cohort. Members of the same cohort often share a common framework. *Frameworks* describes the different perspectives of the three cohorts and suggests how pastors and other church leaders can meet the faith development of those within each cohort.

Seeing the larger church: Confirmands 'say cheese' with a synod bishop at annual gathering - The Lutheran Magazine

ConFEST started six years ago as a way to introduce confirmands to the larger church. "For a lot of these kids, this is the only experience with the wider church they ever get," Larson said, noting that some young people, particularly those in small, rural communities, rarely have opportunities to mingle with people from other synod congregations. Attending ConFEST shows students they aren't alone, either as Lutherans or Christians, she said, adding: "For some this will be the only experience that paints a picture of how we are one in Christ."

The class photos with Larson are taken after a high-energy worship service that includes music by a praise band from the host church as well as a short, inspirational message from the bishop. While plenty of jostling and giggling accompany the setting up for the photo, a baptismal font in the foreground helps remind students of their baptism into the body of Christ. The photos are later sent to the congregations, so prints can be made for each student.

Although Sutherland traveled to Malawi as a teaching pastor last summer, this year his role is that of companion synod coordinator. He looks forward to reconnecting with the saints in Malawi.

When asked about his expectations for the trip, Morck replied, "The one thing I'm looking forward to is to see life from the perspective of the people, or at least try to. Mostly it will be to be with the people that live there and, in the ways we are able, to see life through their eyes. So, it will be everyday matters of social interaction, to the struggles that they face, to the issues of faith and life and how they manage to be church in a place very much different than our own. I am very grateful, honored and humbled to be part of the Pastors' Academy this year. I am thankful for this synod and the way it has embraced this partnership with the Evangelical Lutheran Church in Malawi. I go representing my colleagues and the congregations of this synod and of the ELCA. I go as a pastor to be with pastors and to learn together. I am thankful for the congregation I serve, Central Lutheran of Mondovi, for their partnership in making this happen."

Before the academy begins, the group will have an opportunity to visit different parishes in Malawi. They will also enjoy a safari at Vu Camp.

In 2015, we will host a synod-wide trip for those who are interested in traveling to Malawi. Details will be available later this year. Please remember our brothers and sisters in Malawi, as well as our teaching pastors in your prayers.

Connecting with the Denomination

Just as the congregation or other church unit faces a crisis in transition that needs rethinking of the linkages with the larger church, so the interim leader serving in a connected denominational setting needs to make strong connections with the denominational structures and the staff and committees of the regional and national offices. Thinking systemically, the denomination is part of the context (or a super-system) for the particular church or judicatory. The denominational offices are often able to provide information regarding history and patterns of the church organization which are helpful in analysis.

Furthermore, the committees or staff of the denominational bodies frequently hold the expectations or goals for a particular unit. In many denominations, the interim leader is appointed or recommended by the denominational officers, and serves as a representative of the judicatory.

Connecting with the denomination includes early and regular contact with the head of the next higher judicatory (executive, bishop, president), as well as progress reports to the appropriate board or committee at agreed upon intervals in the interim time. As difficulties arise, consultation with the judicatory's structures and personnel can also be helpful to maintain the detachment required for professional functioning.

Finally, connecting with the denomination is necessary to clarify the judicatory's expectation regarding the interim leader's relationship with the search process for new leadership.

Connecting with the Denomination

Just as the congregation faces a crisis in transition that needs rethinking with the larger church, so the interim pastor needs to make strong connections with the mission area staff and appropriate divisions of the church (for example the Division for Outreach for congregations receiving support from this Division). For the interim pastor the mission area staff is often able to provide information regarding history and patterns of the congregation that are helpful in analysis.

Getting to know the resources available within the mission area and the ELCA for conflict resolution, leadership development, program ministries and congregational development will benefit not only the interim pastor but also help the congregation to develop and re-enforce a sense of partnership in ministry with the mission area and ELCA. Monthly progress reports to the bishop of the synod keep the mission area staff informed as to the status of the congregation and even their readiness for call. As difficulties arise, consultation with the mission area staff can be helpful in maintaining the detachment required to function effectively as interim pastor.

The words are heard Sunday mornings throughout the land. "Hurry up! We'll be late for church." "Do I have to go to church today?" "There's a potluck at church tonight." "When will our church get its new pastor?" In each of those sentences "church" means First Lutheran, Hope Lutheran or Our Savior Lutheran on the corner of First and Main,

Elm and Jackson or out on County Road C five miles from town.

But when people get to that "church," they hear another use of the word. They hear their "church" is sending aid to starving people in Sudan, advocating for peace and justice, and having controversial discussions about sexuality.

Some of those things may also happen at First Lutheran, Hope Lutheran or Our Savior Lutheran. But those activities are certainly occurring in the synods to which those congregations belong and throughout the ELCA's churchwide organization.

Step 5: Tie Together

I am the true vine, and my Father is the vine grower. He removes every branch in me that bears no fruit. Every branch that bears fruit he prunes to make it bear more fruit. You have already been cleansed by the word that I have spoken to you. Abide in me as I abide in you. Just as the branch cannot bear fruit by itself unless it abides in the vine, neither can you unless you abide in me. John 15:1-4

The use of branches in this text seems an appropriate way to illustrate how we are connected to Jesus Christ. We are tied together in the body of Christ. Within the church there are three expressions – congregations, synods and churchwide ministries. These expressions connect each one with other parts of the body of Christ beyond ourselves and facilitate collaborative ministries. What are the ways your congregation is connected to the body of Christ beyond itself?

How do these connections make God's work possible together that could not be done alone? Your responses to these questions demonstrate that you as an individual and a congregation are not alone. Christ is always with us. And, by lifting up what we do together, we see the strength of the body of Christ.

Bacher and Inskeep believe that mainline denominations serve as caretakers of the important American expressions of

Christianity, and if they are weak or lost, society and the universal church will be the worse for it. They argue that a fundamentally American form of mainline denominationalism can and will endure, despite the rumor of its decline. The authors examine six "rumors" of the decline. Using historical trends and current statistical information, they analyze the current situation and point to vital lessons, potential problems, and key challenges. They also offer helpful strategies and provide examples of what denominations are doing that show potential.

Congregationalists and Independents have been historically strong critics of denominationalism. Pentecostals often rejoice at how the gifts of the Spirit draw together Christians of different backgrounds. When the denominations are most true to their traditions, they are most ecumenical. Rethinking Denominational Linkages

Congregations often are not aware of the support and resources they receive from their middle judicatory and national denominational structures. That relationship is normally more visible while the structures of the church beyond the congregation are engaged in working with the congregation in moving through the interim period and seeking to find the right pastor to call. The transition time helps raise the awareness of a congregation to its denominational heritage, ministries and resources.

- give feedback: remind denomination of its duties, promises, and programs
- identify and affirm church members who have' denomination jobs and ties
- identify common interests of church and denomination
- make use of denominational resources: staff, programs, facilities, literature, training, retreats
- allow for ventilation of feelings about denomination

Symptoms of Non-Resolution

- resistance to denominational requests or suggestions
- criticism of denominational personnel and programs
- failure to meet pledges and budgets

Signs of Resolution

- willingness to accept help and resources
- appreciation for the denomination's traditions and missions

The Churching of America, 1776-2005: Winners and Losers in Our Religious Economy [Roger Finke, Rodney Stark]

In this provocative book, Roger Finke and Rodney Stark challenge popular perceptions about American religion. They view the religious environment as a free market economy, where churches compete for souls. The story they tell is one of gains for upstart sects and losses for mainline denominations.

Although many Americans assume that religious participation has declined in America, Finke and Stark present a different picture. In 1776, fewer than 1 in 5 Americans were active in church affairs. Today, church membership includes about 6 out of 10 people. But, as Finke and Stark show, not all denominations benefited. They explain how and why the early nineteenth-century churches began their descent, while two newcomer sects, the Baptists and the Methodists, gained ground. They also analyze why the Methodists then began a long, downward slide, why the Baptists continued to succeed, how the Catholic Church met the competition of ardent Protestant missionaries, and why the Catholic commitment has declined since Vatican II. The authors also explain why ecumenical movements always fail

In short, Americans are not abandoning religion; they have been moving away from established denominations. A "church-sect process" is always under way, Finke and Stark argue, as successful churches lose their organizational vigor and are replaced by less worldly groups.

Some observers assert that the rise in churching rates indicates increased participation, not increased belief. Finke and Stark challenge this as well. They find that those groups that have gained the greatest numbers have demanded that their followers accept traditional doctrines and otherworldliness. They argue that religious organizations can thrive only when they comfort souls and demand sacrifice. When theology becomes too logical, or too secular, it loses people.

The United Church of Christ came into being in 1957 with the union of two Protestant denominations: the Evangelical and Reformed Church and the Congregational Christian Churches. Each of these was, in turn, the result of a union of two earlier traditions.

Why I like denominations - Patheos

For example, most colleges and universities in the U.S. were founded by denominations. So were most hospitals. Most denominations have charitable agencies that are involved in feeding the hungry, training people for jobs, community development, etc. And, of course, most have mission-sending agencies. Small churches that cannot afford to do these things (e.g., found a college or hospital or even support a missionary family) pool their resources better to do them.

Denominations also provide accountability for pastors and other "church professionals." And I think that accountability works best when the authority is closer to the churches and their leaders.

Denominations also keep each other sharp. A certain amount of competition serves to raise the bar, so to speak, so that there is motivation constantly to update, refurbish, stay sharp (e.g., with regard to technology, training for ministry, etc.).

To: Rostered Leaders in the Northwest Synod of Wisconsin

From: Evangelical Leadership Commission, Northwest Synod of Wisconsin

Re: Boundaries with former ELCA congregations and pastors

Date: July 15, 2011

Over the past two years, some congregations and rostered persons have chosen to leave the Evangelical Lutheran Church in America, most of whom have affiliated with a separatist group. In some synods, there have been no departures; in other synods there have been many. To date, seven congregations have left the Northwest Synod of Wisconsin; 205 congregations remain. The departure of sisters and brothers in Christ from our fellowship in the Gospel has been unfortunate and painful.

Long standing relationships with disaffiliated colleagues and congregations are now significantly different. Therefore, we, the Evangelical Leadership Commission of the synod, have consulted with our bishop and wish to offer the following as a reflection regarding appropriate boundaries with former ELCA pastors and congregations.

• First and foremost, we acknowledge the loss of valued colleagues and congregations from our denomination's ministry and mission. We are diminished by their departure, and we grieve that they have chosen to leave us.

• We are grateful that, in spite of their separating themselves from our fellowship, we are still brothers and sisters in Christ in the water and Word of Holy Baptism. For this God-giving unity, we give thanks!

• We welcome the participation of those who have disaffiliated in ELCA ministries that have always been open to all regardless of religious affiliation: Lutheran Disaster Response, Lutheran World Relief, use of Augsburg Fortress material, college and seminary offerings, world hunger efforts, outdoor ministries, etc.

• We understand that those who have disaffiliated will no longer participate in Conference or synod events, gatherings for ELCA rostered leaders and/or congregations, Women of the ELCA, ELCA global companion relationships, Lutheran Youth Organization meetings and gatherings, etc.

We acknowledge and affirm that rostered ELCA clergy, both active and retired, are not to provide pastoral service of any kind for groups who have left or who are taking steps to leave the ELCA, and requests for such from those disaffiliated is inappropriate.
We support interaction and cooperation with disaffiliated pastors and congregations when community-related ministry and mission

benefits from partnerships that go beyond our full communion ecumenical relationships.
We look forward to a future when all God's people are defined by what unifies us in Christ, rather than the differences that separate us.

Again, because relationships have changed, we think it is important to be clear about what constitutes appropriate boundaries to minimize awkwardness and to honor and abide by the polity of our church. We offer our thinking to the other rostered leaders of our synod for your prayerful consideration.

Keynote Address by Bishop Duane Pederson

Walking Together: a congregational resource event March 17, 2013

During the Week of Prayer for Christian Unity this past January, I preached at an ecumenical service at the Roman Catholic Cathedral in Superior and many of our ELCA members and clergy were present. The text was from Micah 6, those familiar words about what the Lord re-quires—to do justice, love kindness, and walk humbly with God.

In the sermon, I said, "Our witness is not to our denomination, but to the Lord who always loves the last, the least, and the lost, and who calls *us* to love the same. I can assure you, the poor and marginalized of our neighborhoods, country, and world could care less if we are Methodists, Roman Catholics, or United Church of Christ. All they hunger for is kind-ness and justice, dignity and fairness. And if we live out Micah's words, they will see the face of Christ in us."

It is my conviction that the mission context in which we live today will require much closer cooperation with other Christian bodies, particularly between congregations in local communities. The local community of faith is the heartbeat of church, gathering around Word and Sacrament and then sent into the world as disciples living for Jesus. And the unity that Christ has already brought into being through baptism into his body, by being steeped in his death and resurrection, will be lived out more and more as old prejudices and doctrinal arrogance give way to cooperation for the sake of witness and service.

If we are serious about introducing an unchurched, disconnected world to the transformative power of Jesus Christ, then we should be partnering every time it makes sense to carry out mission and ministry together.

Study on Catholic Church: Multicultural Parishes Increase as Hispanic Membership Grows in US

The percentage of multicultural Catholic parishes in the U.S. is on the increase, according to research by the Georgetown University-based Center for Applied Research in the Apostolate (CARA). The report also indicates that some 29.7 million U.S. residents who self-identify as Hispanic or Latino are estimated to be Catholic, representing about 59 percent of the 50.5 million people of this race in the country.

Membership of Hispanics in the Catholic Church is growing, reaching to 38 percent, according to the study as presented by the U.S. Conference of Catholic Bishops (USCCB). Non-Hispanic whites are still the majority at 54 percent of the national Catholic population.

This page affirms the commitments of the New Jersey Synod in Assembly in 2002 to Biblical stewardship principles. These expectations are for consideration by each Congregation Council in the synod.

Top Ten Reasons for Congregations to Give 10% (or more) to Mission Support

- 1. Ultimately it is about God and Christ's sacrifice on the Cross. Nothing we can do can earn that love. We are free! Free to respond in service to others.
- 2. Uncharacteristically, we as Lutherans can brag because we have the largest non-profit caring ministry system in our country, Lutheran Services in America, some of the finest colleges, wonderful camps, disaster response and hunger ministries and much, much more that happens when we together pitch in with our tithe to this common work.
- 3. Mission support stops us from taking for granted having pastors and other rostered leaders, educational materials, support for evangelism, stewardship, and other areas of our ministry, all become available because congregations participate generously in mission support.
- 4. Mission support reminds us that we began as congregations because other congregations first helped us when we started out as a mission. It takes us back to our mission roots.
- 5. Generous givers through mission support are motivated by the overwhelming generosity of a loving God who provides for our daily needs. In a small way, we are given the opportunity to say, "Thank You" for our daily bread.
- 6. Generous giving through mission support lifts our spirits and frees us from clutching our possessions too tightly so that those possessions don't possess us. It teaches us that sacrifice can be a "good thing".
- 7. Mission support unites you in a common mission with your brothers and sisters in neighboring congregations as a reminder of how St. Paul understood what it means to be the church together.
- 8. Mission support provides the opportunity for your members to hear inspirational stories of how their mission support makes a difference in another person's life.
- 9. Mission support models for your congregation members the experience of what it means to tithe of their resources to God.
- 10. Mission support is an opportunity for your congregation to discover the joy of giving to God's mission beyond yourselves. It turns us from facing inward all of the time to facing outward to our neighbors.

Why Give ELCA Mission Support: Building the Case

Many congregations ask, "Why give mission support?" For congregations that remember their early days and the role of the larger church in providing guidance and financial support, the answer to this question may be very clear. However, for older congregations the reasons may not be as clear. Actually, the reasons go beyond the age of a congregation. Building the case begins with who we are.

Our Lutheran Identity

As Lutherans, we understand ourselves to have first received from God, and then to respond by giving a portion to God. This faith practice of giving is based on recognizing God's grace, accepting freely and appreciating gratefully God's generosity. As a faith practice, giving is lived out in three ways – in proportion to what we have received, in priority from what was received first, in progressive amounts as one has been blessed. These reflect a core practice that is taught, learned and live out through the ministries of this church.

Our Historical Practice

Individuals are taught, invited and encouraged to practice first fruits giving. Congregations are encouraged to give the first 10% or more of offerings to mission support as a way to make ministries and outreach possible beyond the walls of the congregation. Some congregations have adopted this practice more fervently and give a third or more of their offerings beyond their walls. This practice has inspired more than 200 ELCA congregations to pass on 20% or more of their offerings in mission support. It is this historical practice that has created a model for – it is just what we do!

Our 21st Century Strategy

As the ELCA enters the second decade of the 21st century, two clear priorities have emerged – building capacity for evangelical witness and alleviating poverty by working for justice and peace. The pursuit of these priorities is directly connected to congregations as growing centers for evangelical mission. As we strengthen our partnership, we do together many things that we

could not do alone. One significant way this is made possible is through mission support income from individuals, congregations and synods. This income is the lifeblood of the work God does through the ELCA. Our Competency as Stewards

In bringing forth and supporting faithful, wise and courageous leaders, we engage and shape well-formed stewards. This recognizes the holistic nature of a competent steward – physically, mentally, emotionally, spiritually, financially. These stewards embrace financial health as an expression of faith in this interdependent church. Understanding the perspectives of abundance, grace, gratitude and generosity, faithful stewards express their response through regular offerings, special gifts and planned gifts. These gifts support local ministries and through mission support fund God's work through the ELCA.

Our Constitutional Polity

Financial stewardship within the ELCA recognizes congregations, synods and the churchwide organization as interdependent partners who share responsibility for mission. In this relationship, all share responsibility for ministries and services to develop, implement and strengthen the financial support of the whole church. This partnership is reflected in our mutual ministries of community service, education, discipleship and leadership development.

Q: What is Mission Support?

<u>A:</u> Mission Support is your congregation's financial weekly offering that is shared with your synod and the churchwide organization. It is an undesignated gift to ELCA ministries that go beyond your congregation. These gifts are used where the need is the greatest, and they also make it possible for the ELCA's 65 synods and the churchwide organization to keep ongoing commitments to ministry partners.

Q: What guides the churchwide organization in its decisions regarding Mission Support?

<u>A:</u> Churchwide Assemblies – this church's highest legislative authority – guides and directs the work of the churchwide organization. The ELCA Church Council functions as the interim legislative authority between assemblies. The churchwide organization's two strategic priorities are to accompany the nearly 10,000 congregations as growing centers for evangelical mission and to build the capacity of this church for evangelical witness and service in the world to alleviate poverty and to work for justice and peace. We are a church that believes God is calling us into the world – together.

<u>Q:</u> How does my congregation benefit from Mission Support?

<u>A:</u> Every congregation benefits as an active partner in the ELCA's mission to share God's love with the world. Mission Support funds the work of synods, and some of the portion of Mission Support that is shared with the churchwide organization returns back to your congregation and synod in the form of services, programs, resources or grants. Typically, more than 90 percent of a congregation's offering remains in the congregation to help pay for local ministries, outreach, salaries, utilities and the building, ensuring your congregation's vital presence in your community. We are a church whose unity is in Jesus Christ, who gathers us around word and water, wine and bread. Together — we can do more than any congregation or synod could do alone.

Resource Center 2.0: Today it's more about networking than materials on hand - The Lutheran Magazine

If Lutherans were asked to define resource center, how many would respond along the lines of "a place for books and DVDs"? Perhaps some of the savvier would add that the center's catalog is online.

But ask directors of ELCA resource centers the same question, and you'll get a different response. Darlene Kalfahs, resource director for the East Central Synod of Wisconsin in Appleton, said it's a place for lay and clergy leaders "to discover resources, share ideas and brainstorm with experienced people who truly care about the ministry they do."

Karen Kaufman of the Northeastern Ohio Synod Resource Center, Cuyahoga Falls, said it's "a link to a vast network of human and published resources" that support and inspire congregational leaders.

As an example, Julie Aageson, resource director for the Eastern North Dakota Synod, recounted a recent conversation with a firstcall pastor. He told her the small congregation had no history of a Christian education committee. Instead, the council would identify a person to coordinate all education for a three-year term, at the end of which the member typically felt burned out and left the church.

The Principle of Partners

Wilberforce could not do any of these things by himself. When you make a movie, you're making Wilberforce a heroic figure. But really The Clapham Group were the people that surrounded him, and they are in the movie. The people in this group were so committed to Christ, to the purpose of abolition and to each other that they all moved to Clapham. Some of them were already living there, but Wilberforce moved to Clapham and they all had houses around Clapham Commons, which was a big circular park outside of London. This was a little village in those days. The church sits on one end of the commons and they built their houses around it. They literally became known as the Clapham Circle. When God calls us to His purposes, it's rarely something he calls us to alone. Usually it is something that He's called us to where there are other like-minded brothers and sisters.

Mission Partners - New England Synod | ELCA

What is the purpose of mission partners?

Its purpose is to bring congregations into direct and personal relationships, yielding benefits to both partners. For example, established congregations are always enriched and often awakened to a new sense of mission through their involvement with a

new mission-start, or a renewed urban ministry; and new and renewed congregations receive needed support and encouragement from established partners.

What does the name signify?

"Mission" describes our central purpose as the church – every congregation is called to be in mission in its own neighborhood. "Partners" describes another basic reality of our faith, the strength we achieve through common action in mission.

What is exchanged in this partnership?

Prayers – Publicly or privately praying for the ministry, the people, and the pastor of the partner congregation.

Presence – Sharing in firsthand interaction with the people of the partner congregation as they engage in ministry.

Presents – Tangible expressions of support, such as... things (supplies, equipment, etc)... funds (dollars to help underwrite the ministry of the partner congregation. Also, helping with funds for capital expenses, staff, etc.)... services (volunteering to help in the partner's ministry as needed.

What is a mission partner's covenant?

A Mission Partners Covenant is a formal agreement between two congregations 📙 Mission Partner Agreement or between an

individual and a congregation Assisting Partner Friends Form, listing specific commitments for their partnership in ministry and the length of the commitment. - **C12.04.** The Congregation Council shall have general oversight of the life and activities of this congregation, and in particular its worship life, to the end that everything be done in accordance with the Word of God and the faith and practice of the Evangelical Lutheran Church in America. The duties of the Congregation Council shall include the following:
 - i. To emphasize partnership with the synod and churchwide organization of the Evangelical Lutheran Church in America as well as cooperation with other congregations, both Lutheran and non-Lutheran, subject to established policies of the synod and the Evangelical Lutheran Church in America.

Lutheran usage[edit]

In <u>Lutheran</u> traditions, a synod can be on the one hand (e.g. in North America) an administrative region or entire church body or on the other hand (e.g. in Europe) a legislative body on different levels of the church administration.

 A synod as a local administrative region is similar to a <u>diocese</u> in other denominations, such as the <u>Minneapolis Area Synod</u> of the <u>Evangelical Lutheran Church in America</u>. Whereas with the <u>Lutheran Church–Missouri Synod</u> it denotes an entire church body. The usage of synod as an administrative ecclesiastical region is reflected by the German term Synodalverband (i.e. synodal federation), such as the <u>Regional Synodal Federation of the Free City of Danzig</u>.
